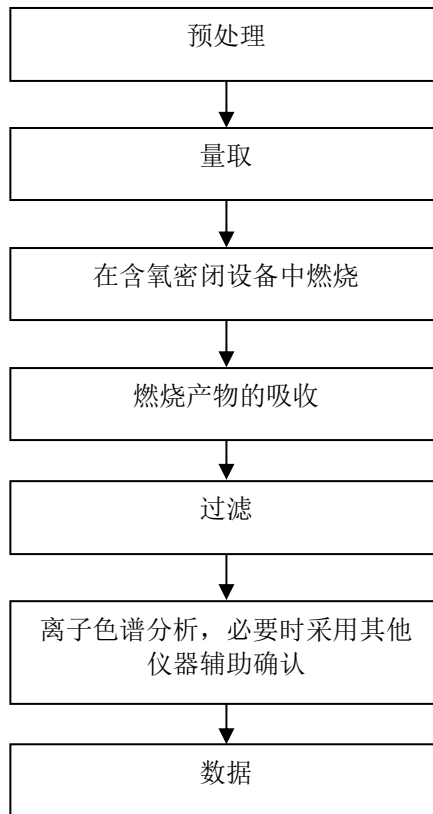

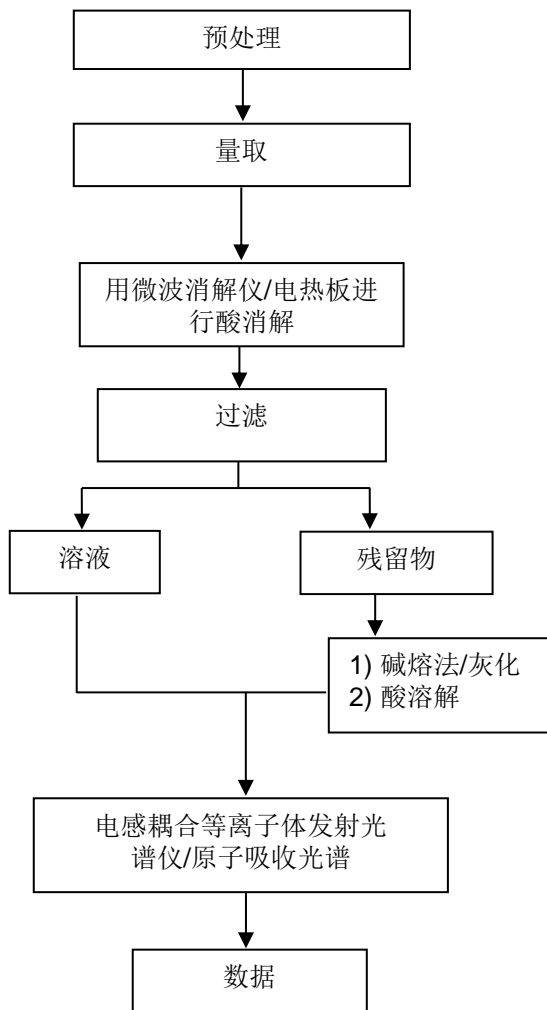


## 卤素检测流程图

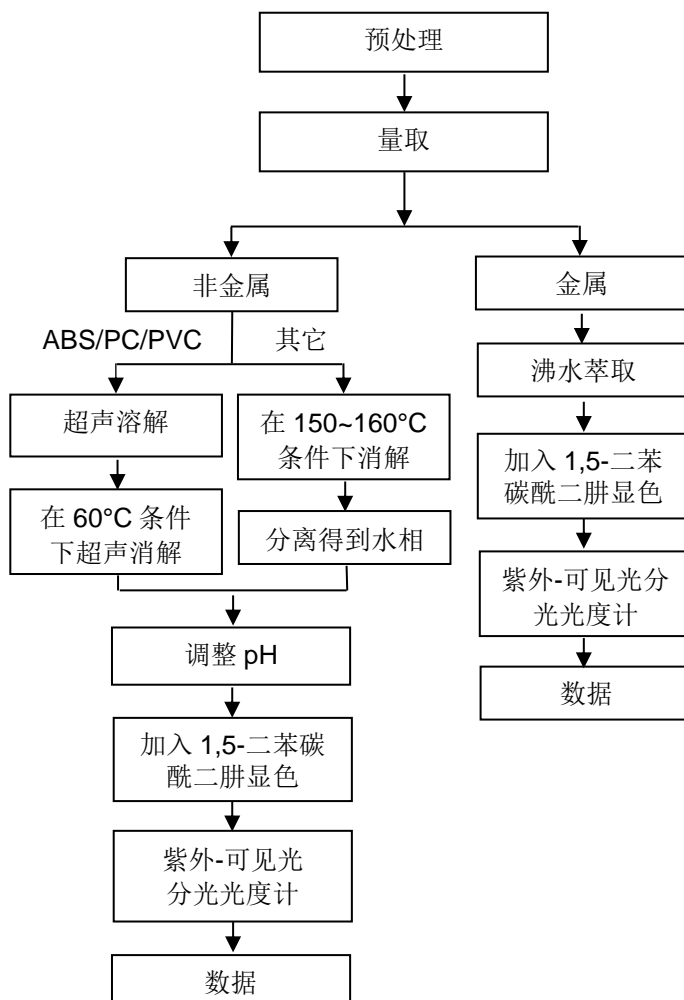

### 六价铬检测流程图

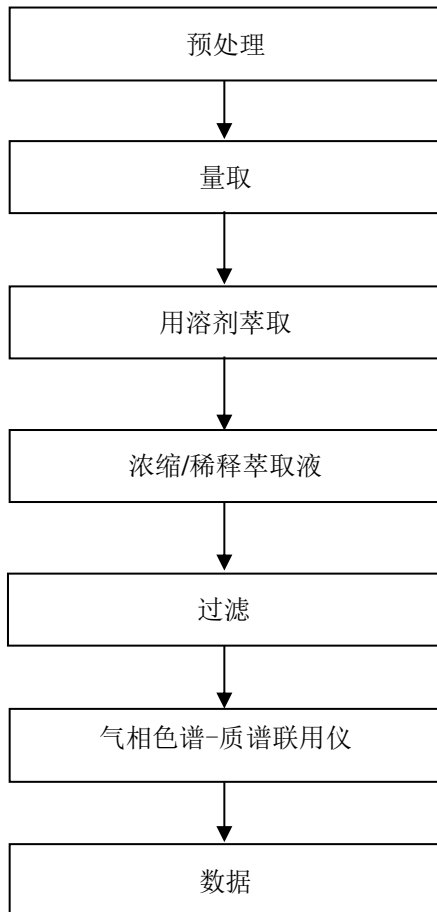

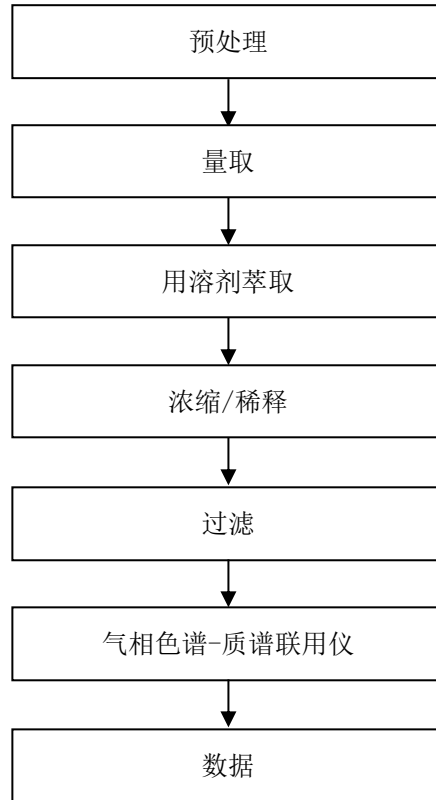

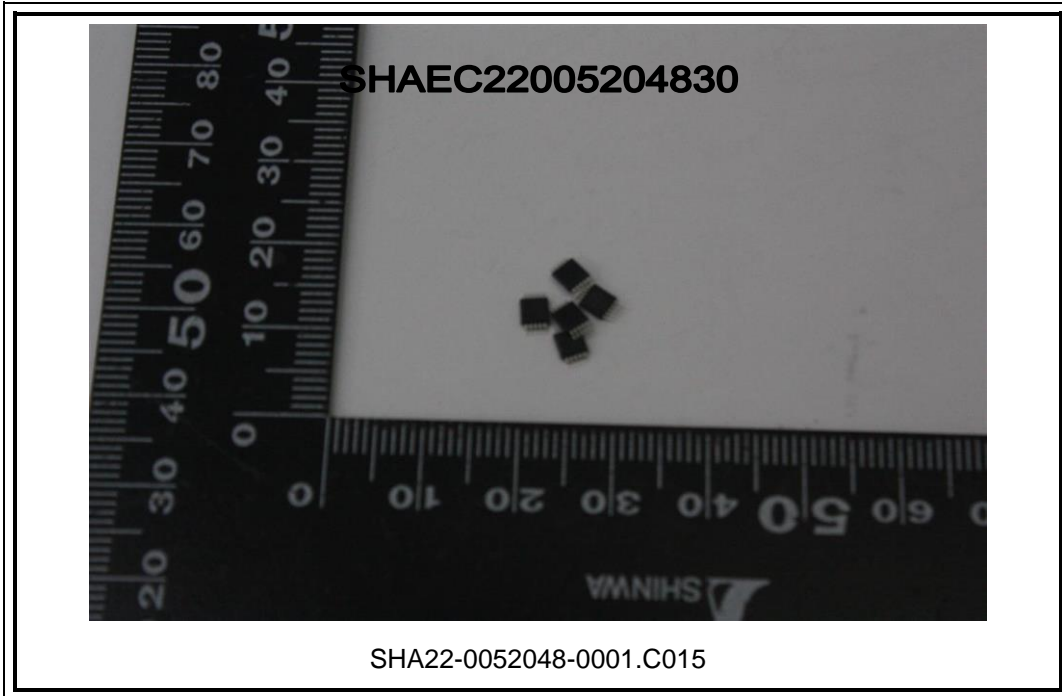
