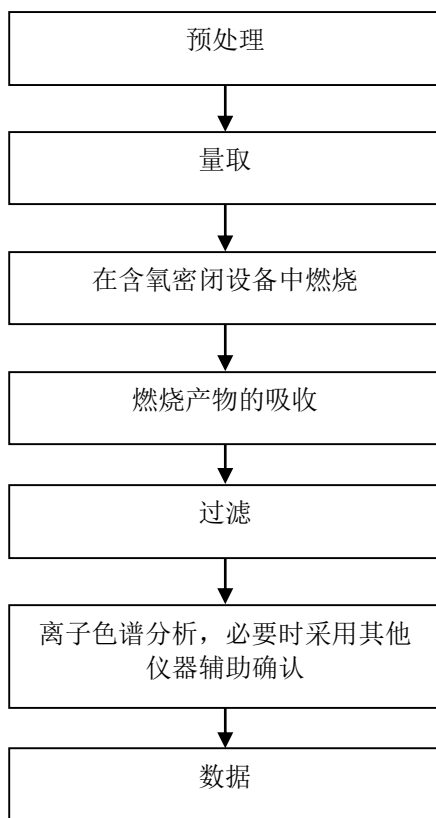

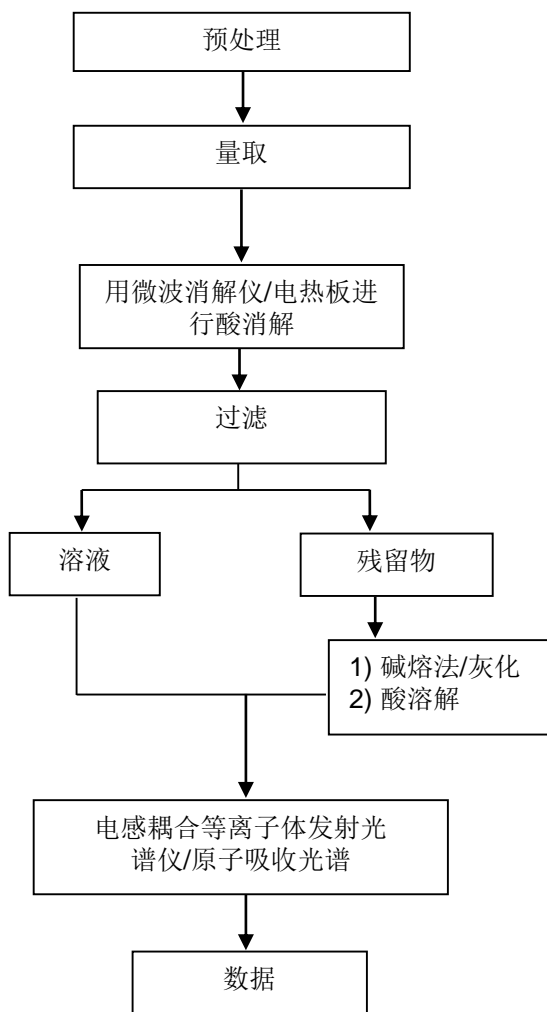

元素 (IEC62321) 检测流程图

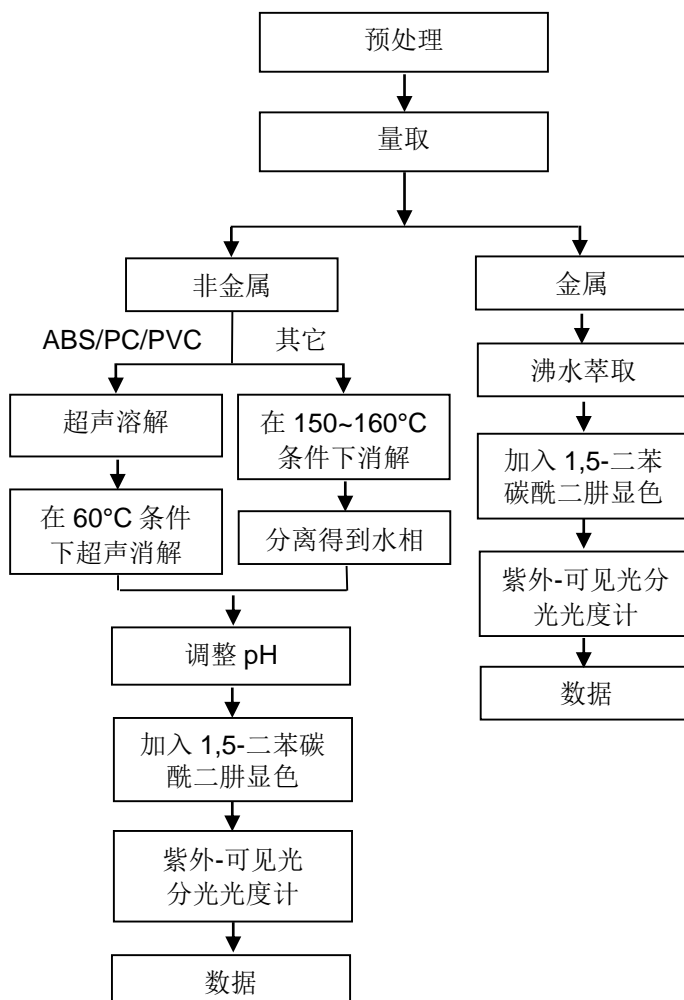

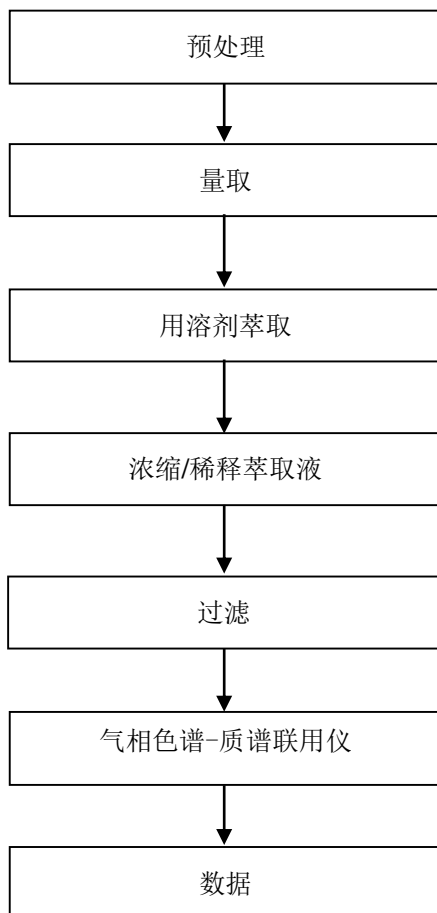

PBBs/PBDEs 检测流程图



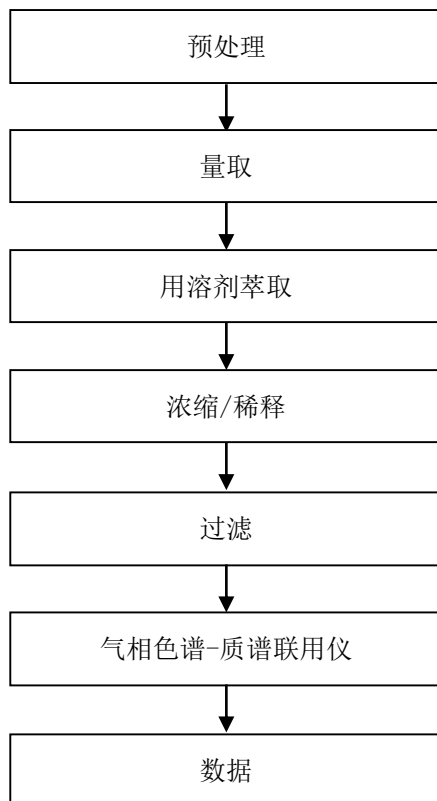

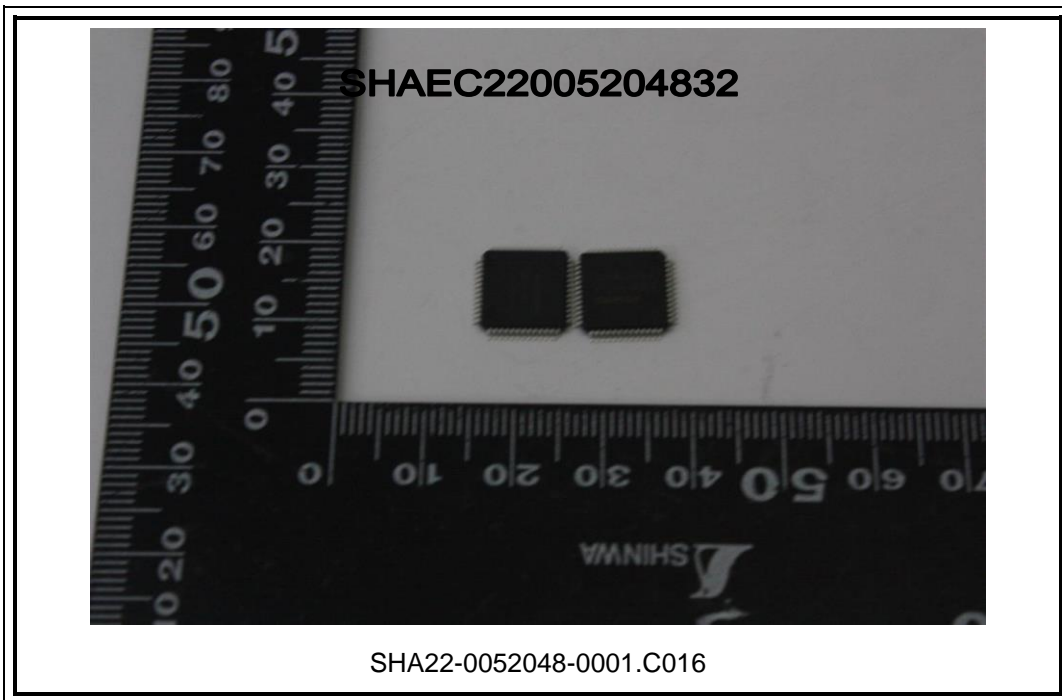
